Actions carried forward:

2651 No further information or update was available on the anti-social issues linked to the pub. This may be linked to the colder and wetter weather. PCllrs would keep an eye out for any resident complaints.

2799 A resident was very concerned about a tree surrounded by vegetation/ old bushy branches, collected and positioned by visitors to the woods as a fire risk. The Chair had taken photos of the dead Fir and had contacted two officers at Bedford Estate. A bonfire had also been spotted in the car park and reported. It was felt that more signs were needed to warn visitors of lighting fires.

2814 A resident spoke on behalf of herself and three other neighbours about the issues they were having with customers and noise at the Royal Oak. Since the weather had got warmer the resident reported that more anti-social events had taken place outside the pub including drug taking. The four residents all had cameras installed on their properties which had

captured people consuming alcohol on Church road and in their gardens, vomiting on their property, accessing steps, doorsteps and gardens, preparing and taking drugs. Glasses, bottles and cans were left on Church Road and Sandy Lane with groups of people walking around the corner and returning soon after which seemed suspicious. The residents had been in contact with CBC who had asked them to log all events. The residents were asked by Members to contact the Police with any evidence of illegalities and ask that the call also be reported to the Local Neighbourhood team. The resident agreed to send their evidence to the Council and was thanked for providing such detailed information. The resident was advised that CCTV would be installed which would capture some of the issues outside the pub. Members agreed to contact licensing at CBC to ask for the licensing documentation as there was also an issue with music being played at the pub until 12am both inside and outside.

2829 Central Bedfordshire Councillor Report

2800 CBCllr Baker had asked for residents' views on the BOAT closure. If they wanted it to remain closed they would need to give evidence for the benefits of this. The Parish Council would also submit comments after the summer. A resident had said that anti-social behaviour had reduced significantly since the closure.

The Clerk had contacted Francine Rainbow who had stated that the work had been ordered and that Chris Nicholl would be seeing this through. No action had been taken by CBC yet. The Clerk would contact Chris again to see if this was being actioned and copy in CBCllr Baker. The location and wording of the sign would need to be agreed. Several vehicles were accessing Sandy Lane every day and causing problems with erosion of the BOAT and access. The Chair and the Clerk would email Chris Nicoll at CBC again as no response had been made.
